User Guide









- Step 1.
- With the outer nose-clip facing up, place the mask over the face to cover both nose and mouth.
- Step 2.
- Pull the left and right ear straps around each ear for a comfortable fit.

- Step 3.
- Using both hands, press the outer nose-clip inward to comfortably form to and support the nose bridge.
- Step 4.
- Check for air leakage around the face by breathing in-and-out and continue to adjust the mask to achieve a proper fit.
